

PAS 2035

- A government backed quality standard for retrofit (which we helped develop!)
- PAS 2035 covers:
 - how to assess dwellings for retrofit
 - identifying the right improvements for the right homes
 - the design and specification of energy efficiency measures for installation
 - monitoring of retrofit projects
- It outlines a 'Whole House' approach to the retrofit process
- Mandatory for public funded projects- ECO, SHDF, GBIS etc



Qualified DEAs can upskill to become a Retrofit Assessor

- ❖ Dwellings which require energy retrofit work in accordance with PAS 2035 will need be assessed by an approved Retrofit Assessor
- ❖ Training available to enjoy on demand or face-to-face
- ❖ Our course expands the skills and knowledge of a DEA so they can deliver Condition Reports, and assessment of occupancy

Busier than ever

- More focus on energy efficiency, carbon emissions and fuel poverty
- More funding schemes than ever
- Delays in responses to some consultations, e.g. PRS MEES and lenders



Retrofit and Energy are the future

- DEAs and retrofit professionals are key to low carbon homes
- EPC reform 2026
- Home Energy model (HEM)
- PRS minimum energy efficiency standards (MEES)
- Efficiency Standard for Social Housing (ESSH) requires homes to meet or be treated as meeting EPC band B by December 2032
